

# Summary of BCRU Discipline Rulings for 2022/23 Season

## <u>Please see below for a summary of BCRU Disciplinary Rulings for the 2022/23 Senior</u> <u>Club Season:</u>

**Brian MacKinnon** of Kamloops RFC was ejected from the September 10, 2022 Men's Div 3 match vs Kelowna by referee Anders Fahlgren for contravening Law 9.12 (physical abuse- striking)

**Suspension:** 6 games, reduced by mitigation to 4 games (1 game credit is given for defaulted game on September 17th)

**Clay Markoff (**originally reported as Cody) of Seattle was ejected from the September 10, 2022 Men's Premier match vs Burnaby Lake by referee Armel Durrand-Badel for contravening Law 9.18 (dangerous lifting of opponent)

Suspension: 6 games reduced by mitigation to 3 games

**"Name not reported"** of United Rugby was ejected from the September 17, 2022 Men's Div 3 match vs Langley RFC by referee Joel Van Meer for contravening Law 9.10 (repeated infringement by a team)

Suspension: Time served

**Glen McKinnon** of Capilano Rugby was ejected from the September 17, 2022 Men's Premier match vs Meraloma by referee Dave Smortchevsky for contravening Law 9.9 (repeated infringement by a player, 2 yellow cards in a match)

Suspension: 1 game

**Paul Kelly** of Surrey Beavers Rugby was ejected from the September 24, 2022 Men's Division 1 match vs Nanaimo by referee Lee Burridge for contravening Law 9.9 (repeated infringement by a player, 2 yellow cards in a match)

Suspension: 1 game (served on October 1, 2022)

**Max Stewart** of Pacific Pride Rugby was ejected from the September 24, 2022 Men's Premier match vs UVic by referee Shanda Assmus for contravening Law 9.9 (repeated infringement by a player, 2 yellow cards in a match)

Suspension: 1 game (served on October 1, 2022)

**Genvieve Bittorf** of Capilano Rugby was ejected from the October 1, 2022 Women's Division 1 match vs Burnaby by referee T Zhang for contravening Law 9.13 (dangerous tackle)

Suspension: 2 games reduced by mitigation to 1 game

**Paul Kelly** has been found to have breached 5.3 (a) and 6.6 (e) of the BCRU Code of Conduct for referee abuse.

Suspension: 2 games

**James Kelly** has been found to have breached 5.3 (a) and 6.6 (e) of the BCRU Code of Conduct for referee abuse.

Suspension: 6 games

**Pace Peters** of Castaway Wanderers was cited by JBAA for foul play in the October 1st, 2022 Premier men's game. The Citing Officer found that the citing had merit. The Committee found that he had breached Law 9.20 (dangerous play in a ruck)

Suspension: 2 games, reduced by mitigation to 1 game

**Mike Newuinhauser** of JBAA was ejected from the October 1, 2022 Men's Div 1 match vs Castaway Wanderers by referee Chris Horsley for contravening Law 9.12 (striking).

**Suspension:** 6 games reduced by mitigation to 3 games. A further 1 game suspension was added because he breached BCRU Discipline Policy "7.3 (e) the player is not eligible to play pending resolution of the case". **Total suspension:** 4 games

**Clayton Morgan**, a coach with Langley U-18 Boys, was sent away from the October 2, 2022 match vs Bayside by referee Doug Thorpe for contravening Law 9.28. The Committee found that he had breached section 16.2 of the BCRU Discipline Policy and section 5.3 (a), (b) and (c) of the BCRU Code of Conduct.

Michael Palmer of UVic was ejected from the October 22, 2022 match vs Comox by referee Chris Brown for contravening Law 9.13 (Dangerous Tackling) Suspension: 2 games reduced by mitigation to time served.

**Amillo Romero** of Burnaby Lake was ejected from the October 23, 2022 match vs Meraloma by referee John Bay for contravening Law 9.16 (dangerous tackling).

**Suspension:** 6 games reduced by mitigation to 3 games (Note: the suspension will begin after the player has supplied the Committee with documentation that he has completed the Concussion Graduated Return to Play Protocol and has been cleared to play by a doctor)

Matt Percillier has been found to have breached the BCRU Code of Conduct, section 5.3, section 6.6 (a) and (b), the Viasport Universal Code of Conduct Section 5.12 and 5.13 and Law 9.28 for making physical contact with a Match Official.
Suspension: 6 games reduced by mitigation to 3 games

Michael MacLellan of Burnaby Lake RFC was cited by Kats RFC for foul play in the Division 2 match played on October 29, 2022. The Discipline Committee found that the citing had merit and that he had contravened Law 9.11 (dangerous play) Suspension: 6 games reduced by mitigation to 2 games

**MacKenzie Mills** of Capilano RFC was cited by UVic RFC for foul play in the Men's Premier Reserve match played on October 29th, 2022. The Citing Representative found that the citing had merit and that he had contravened Law 9.12 (Striking with an arm and a knee)

Jared Curry of Kelowna Crows RFC was ejected from the November 19<sup>th</sup>, 2022, Men's Div 1 match vs Abbotsford RFC by referee Brett Hay for contravening Law 9.27 (sportsmanship). He was also found to have breached section 6.6 a) of the BCRU Code of Conduct Suspension: 1 game.

Mitch Day of Kamloops RFC was cited by Bayside RFC for dangerous play during a November 19<sup>th</sup>, 2022, Men's Div 1 match vs Bayside RFC. The Committee found that the citing had merit and that he had contravened Law 9.12 (striking).
 Suspension: 6 games reduced by mitigation to 3 games.

Capilano RFC, Meraloma RFC, Vancouver Rowers RFC and UBCOB Ravens RFC. Some members of the mentioned clubs' Men's Premier and Premier Reserve teams were found to have breached sections 15 and 16 of the BCRU Discipline Policy, for misbehaviour during a November 5<sup>th</sup>, 2022, voyage on a BC Ferry.

### Discipline:

- 1) That each of the four mentioned clubs be placed under probation until August 31, 2023.
- 2) That each of the four mentioned clubs post a \$1,000 bond with the BCRU.
- 3) That if, between the date of this ruling and August 31, 2023, there are no reported incidents of misbehaviour breaching Section 15 and 16 of the BCRU Discipline Policy by members of the individual mentioned clubs, that club's bond be returned to the club.
- 4) That each of the four mentioned clubs be fined \$500, payable to the BCRU.
- 5) That each of the four mentioned clubs: 1) prepare a document stating the club's Code of Conduct with respect to its behaviour expectations for members during travel on BC Ferry vessels, 2) implement action plans to ensure compliance of their members with the behaviour expectations and 3) send a written report of the behaviour expectations and implementation of the action plans to the BCRU, to be received by February 1, 2023.
- 6) That the BCRU Competition Committee and Board investigate the policy and process for forfeiture of league points by the four mentioned clubs.
- 7) That the BCRU Board consider amendments to section 15 of the BCRU Discipline Policy to clarify expectations of clubs while travelling on BC Ferry vessels.

 Suspension: 8 games reduced by mitigation to 4 games

Blaine Meek of UBCOB Ravens RFC was ejected from the February 4th, 2023, Men's Premier Reserve match vs Capilano RFC by referee Riley Robinson for contravening Law 9.12 (striking).
 Suspension: 2 games reduced by mitigation to 1 game
