



# SUMMARY OF BCRU DISCIPLINE RULINGS FOR 2025/26 SEASON

Please see below for a summary of BC Rugby Disciplinary Rulings for the 2025/26 Senior Club Season:

Updated as of May 26, 2026

May 13, 2026

**Josh Waller** of Vancouver Rowing Club RFC was sent off by referee Kristine Lovatt (on the advice of Assistant Referee Phil Webster) for contravening Law 9.12 (physical abuse: striking) during a May 9, 2026 Men's Div 1 Provincial Final game vs Capilano RFC

**Sanction:** 6 games increased by aggravating factors to 8 games and reduced by mitigating factors to 4 games

**Jordan Heeney** Vancouver Rowing Club was cited by Burnaby Lake for contravening Law 9.13 (Dangerous tackling) during the Provincial Men's Div 3 Final on May 9, 2026.

**Sanction:** 8 games reduced by mitigating factors to 5 games

The DC received a citing from Westshore Premier Women, alleging that Teya Ashworth, of Vancouver Thunderbirds, contravened Law 9.20 b) during the BC Rugby Provincial Final on May 9, 2026

**Ruling:** That the actions of Teya Ashworth were not worthy of a sending off. The DC will take no further action.

May 6, 2026

**Kendra Cousineau** of Westshore RFC was sent off by referee Juan Rey for contravening Law 9.28 (verbal abuse of a match official) during a May 2, 2026 Premier Women's Playoff round 1 game vs Meraloma Premier Women





**Sanction:** 2 games reduced by mitigating factors to Time Served in the Match

The DC received 2 complaints of misconduct by supporters of the Surrey Beavers RFC during an April 25<sup>th</sup> match vs Kats. Incident #1 verbal abuse which brings BC Rugby into disrepute and Incident #2, verbal abuse of match officials.

**Ruling:** that on the balance of probabilities the misconduct occurred as described to the DC.

**Sanctions:**

- fines: incident #1: \$250.00, incident #2: \$500.00
- club to post a \$1,000.00 behaviour bond until August 31, 2027
- club to have supporter marshals at all of the Club's mens games.

### April 29, 2026

The DC received a complaint by Vancouver Rowing Club alleging breaches of the BC Rugby Code of Conduct by a member of the Abbotsford RFC.

**Ruling:** As the DC did not have clear and un-contradicted evidence of the breaches, it took no further action.

**Josh Seo** of Abbotsford RFC MD-3 was sent off by referee Rupert Whiting for contravening Law 9.18 (dangerous tackling: tip tackle) during an April 25<sup>th</sup> match vs Rowing club MD-3.

**Sanction:** 8 games reduced by mitigating factors to 4 games

**Paul Kelly** of Surrey Beavers was sent off by referee Joel Van Meer for contravening Law 9.28 (verbal abuse of a match official) during an April 25<sup>th</sup> match vs Kats.

**Sanction:** 4 games

**Adam Lamond** of Kelowna Crows RFC MD-3 was sent off by referee Jeremey Duncan for contravening Law 9.12 (striking) during an April 25<sup>th</sup> match with Burnaby Lake MD-3.

**Sanction:** 4 games reduced by mitigating factors to 2 games.





**Raul Chapa** of Burnaby Lake RFC MD-3 was sent off by referee Jeremy Duncan for contravening Law 9.18 (lifting an opponent and dropping them onto their head/shoulders) during an April 25<sup>th</sup> match vs Kelowna Crows MD-3

**Sanction:** 7 games reduced by mitigating factors to 3 games.

The DC revisited its April 15<sup>th</sup>, 2026 ruling suspending Manraj Randhawa. The DC ruled that some evidence it used in its April 15<sup>th</sup> hearing was shown to be incorrect.

**Sanction:** 6 games reduced by mitigating factors to 3 games.

### April 15, 2026

**Admir Cejvanovich** was found to have breached Law 9.28 and Code of Conduct 6.6 for verbally abusing the match officials after a March 28, 2026 Premier men's match vs Ravens

**Sanction:** 12 games reduced by mitigating factors to 8 games

**Andrew Wainwright** of Chilliwack RFC was sent off by referee Thomas Cooper for contravening Law 9.18 (dangerous tackling-tip tackle) during an April 11, 2026, Division 2 Men's match vs Richmond RFC.

**Sanction:** 6 games reduced by mitigating factors to 3 games

**Tanner Hoskins** of Rowers RFC was sent off by referee Jeremy Duncan for contravening Law 9.12 (striking) during an April 11, 2026 Men's D-3 match vs Abbotsford

**Sanction:** 6 games reduced by mitigating factors to 3 games

**Manraj Randhawa** of Abbotsford RFC was sent off by referee Jivan Dhaliwal for contravening Law 9.18 (dangerous tackling-tip tackle) during an April 11, 2026, Division 1 Men's match vs Rowers RFC.

**Sanction:** 8 games reduced by mitigating factors to 5 games

**Miller Thind** of Ridge Meadows RFC was sent off by referee Phil Webster for contravening Law 9.29 (2 yellow cards in a match) during a January 31, 2026 Men's D3 match vs Kats

**Sanction:** 1 game (credit given for a Ridge Meadows match on February 7, 2026)





**Jessica Picco** of SFU RFC was sent off by referee John Bay for contravening Law 9.13 (dangerous tackling) during a February 7, 2026 Women's D2 match vs Kelowna.  
**Sanction:** Time served in the match

**Brady Nooski** of Axemen RFC was sent off by referee Jivan Dhaliwal for contravening Law 9.13 (Dangerous tackling) during a February 7, 2026 Men's D3 match vs Capilano.  
**Sanction:** 2 games reduced by mitigating factors to 1 game

**Sanction:** 3 games reduced by mitigating factors to 1 game

**Lehlo Walmsley** of Scribes RFC was sent off by referee Rupert Whiting (on the advice of AR Leighton Williams) for contravening Law 9.12 (physical abuse: striking with a fist) during the January 17<sup>th</sup> Men's D3 match vs Kelowna RFC.  
**Sanction:** 3 games reduced by mitigating factors to 1 game

**Nick Warmerdam** a supporter of Abbotsford RFC, was found to have breached sections of the Code of Conduct by verbally abusing a match official during a November 23, 2025 match vs Capilano RFC.  
**Sanction:** Nick Warmerdam is banned from BC Rugby Events until August 31, 2026 and then on probation until January 1, 2027, Abbotsford RFC must: post a \$1000 performance bond until August 31, 2026, appoint "sideline marshals" to their home games and produce a club Code of Conduct and action plans to implement it.

**A Player of Uvic RFC** was alleged, by JBAA RFC, to have breached the BC Rugby Code of Conduct by uttering racial slurs during a November 29<sup>th</sup> Mens D1 match.





Sanction: After an investigation, the DC will take no further action
